Reminder: You have a balance due; IRS has ways to help you

During the pandemic, the IRS suspended mailing some collection notices while we continued to process tax returns and correspondence. We are resuming normal operations and providing this update on your outstanding balance to help you stay informed. This notice shows the amount you owe, including interest and penalties, and offers options to help you pay your balance. The amount below reflects any penalty relief you may have automatically received related to the suspension of notices.

Did you know you can access your IRS account information online?

Pay over time

If you owe more than \$100,000 and can't pay your full balance, please call us at 800-829-3903 or complete Form 9465, Installment Agreement Request. Visit IRS.gov/forms to locate instructions and download a copy of the form.

Offer in Compromise (OIC)

An offer in compromise lets you settle your tax debt for less than the full amount you owe. Use the OIC Pre-Qualifier tool at **IRS.gov/offers** to see if you qualify, to calculate a preliminary offer amount, or to learn more about the program. Use of this tool does not guarantee offer acceptance.

Temporarily delay collection

If you're experiencing financial hardship, we may be able to temporarily delay collection until your situation improves. Visit **IRS.gov/delay** to learn more.
