What you need to do

Pay the amount you owe by December 23, 2024 to avoid additional interest and any applicable penalties.

- **Pay your balance online now** by visiting [IRS.gov/payments](https://www.irs.gov/payments) on a computer or mobile device. It's fast, secure, and you'll receive instant confirmation of your payment. Pay directly from your bank account, credit or debit card, or digital wallet.
- **Pay by mail.** Make your check or money order payable to United States Treasury. Be sure to attach the payment stub included at the end of this notice when you mail your check or money order.

If you can't pay the full amount you owe right now, consider the following options:

- **Make arrangements to pay over time.** If you owe less than \$100,000, visit [IRS.gov/paymentplans](https://www.irs.gov/paymentplans) to apply for a payment plan.
- **Consider an Offer in Compromise (OIC).** Use the OIC Pre-Qualifier tool at [IRS.gov/offers](https://www.irs.gov/offers) to see if you qualify, to calculate a preliminary offer amount, or to learn more about the program.
- **Temporarily delay collection.** If you're experiencing financial hardship, the IRS may temporarily delay collection until your situation improves. Visit [IRS.gov/delay](https://www.irs.gov/delay) to learn more.
